PROJECT DESCRIPTION	
THIS PROJECT CONSISTS OF IMPROVEMENTS AT THE INTERSTATE 76 REST AREA IN BOTH EASTBOUND AND WESTBOUND DIRECTIONS, WHICH IS LOCATED ABOUT 6.5 MILES EAST OF ROOTSTOWN IN PORTAGE COUNTY. THE IMPROVEMENT CONSISTS OF CONFIGURING A NEW PARKING AREA WITH DIAGONAL TRUCK PARKING. TRUCK PARKING INCLUDES FULL DEPTH CONCRETE PAVEMENT WITH FULL DEPTH ASPHALT PAVEMENT BEING USED ON PASSENGER VEHICLE PARKING REAS. IMPROVEMENTS ALSO INCLUDE STORM SEWER INSTALLATION, SANITARY SEWER INSTALLATION, PAVEMENT STRIPING AND SIGNAGE. REST AREA BUILDING IMPROVEMENTS ARE BEING PERFORMED UNDER SEPARATE CONTRACT BY OTHERS.
