COMMENCEMENT AND PROCEDURE

ALL ITEMS TO BE DEMOLISHED OR REMOVED UNDER THIS CONTRACT WILL NOT ALL BE RELEASED TO THE CONTRACTOR FOR DEMOLITION OR REMOVAL AT ONE TIME, BUT WILL BE RELEASED INDIVIDUALLY OR IN GROUPS AS RIGHT-OF-WAY NEGOTIATIONS ARE COMPLETED, AND BUILDINGS ARE VACATED. THE CONTRACTOR WILL BE NOTIFIED BY THE PROJECT ENGINEER WHEN ITEMS STATED ABOVE ARE AVAILABLE FOR DEMOLITION OR REMOVAL. SEVEN (7) WORKING DAYS AFTER THE DATE OF NOTIFICATION (TO INCLUDE THE EPA WAITING PERIOD. SEE "NOTIFICATION OF EPA" SECTION) WILL CONSTITUTE THE STARTING DATE FOR THE REMOVAL PERIOD AS CALCULATED UNDER THE "COMPLETION DATE SCHEDULE" OUTLINED IN THE NOTE.

FAILURE TO MEET THE LISTED TIME CONSTRAINTS WITHIN THE PLAN WILL RESULT IN THE CONTRACTOR BEING ASSESSED LIQUIDATED DAMAGES IN THE AMOUNT OF \$2000.00 PER CALENDAR DAY BEYOND THE INDICATED TIME PERIOD.

NO ITEM WILL BE BURNED UNLESS THE CONTRACTOR TEST AND/OR ABATES ANY ASBESTOS MATERIAL NOT REQUIRED TO BE REMOVED FOR DEMOLITION. THE CONTRACTOR MUST OBTAIN THE APPLICABLE PERMITS FROM THE LOCAL GOVERNING AGENCIES.

STORM WATER POLLUTION PREVENTION PLAN (SWPPP)

A STORM WATER POLLUTION PREVENTION PLAN (SWPPP) WILL BE DEVELOPED AND MUST BE ADHERED TO IN ORDER TO PREVENT SEDIMENT AND/OR RUNOFF ASSOCIATED WITH CONSTRUCTION ACTIVITIES FROM ENTERING THE CANTON CITY WATER WELL FIELD LOCATED EAST OF THE PROJECT. THE CONTRACTOR SHALL BE RESPONSIBLE FOR COORDINATING ALL PROJECT ACTIVITIES WITH THE CANTON CITY WATER DEPARTMENT FOR THEIR APPROVAL, ALONG WITH THE DEVELOPMENT OF A SWPPP, BEFORE CONSTRUCTION ACTIVITY CAN TAKE PLACE. WATER QUALITY PRACTICES SHALL BE INCORPORATED INTO THE PROJECT SWPPP PLAN TO PREVENT UNTREATED STORM WATER TO BE DISCHARGED IN THE WATER WELL FIELD. THE PROJECT SWPPP PLAN SHALL BE SUBMITTED TO THE CANTON CITY WATER DEPARTMENT FOR REVIEW AND COMMENT BEFORE CONSTRUCTION ACTIVITY CAN TAKE PLACE.

BEST MANAGEMENT PRACTICES FOR TEMPORARY AND PERMANENT SOIL EROSION/SEDIMENT CONTROL AND WATER POLLUTION CONTROLS SHALL BE IMPLEMENTED THROUGHOUT CONSTRUCTION ACTIVITIES IN ACCORDANCE WITH ODOT'S CONSTRUCTION MATERIAL SPECIFICATIONS (CMS), THE SWPPP, AND ALL OTHER APPLICABLE SUPPLEMENTAL SPECIFICATIONS. ALL SOIL EROSION AND SEDIMENT MEASURES SPECIFIED IN THE SWPPP SHALL BE IN PLACE PRIOR TO ANY CLEARING AND GRUBBING, EXCAVATING, GRADING OR FILLING OPERATIONS AND INSTALLATION OF PROPOSED STRUCTURES OR UTILITIES, AND SHALL REMAIN IN PLACE UNTIL CONSTRUCTION IS COMPLETE AND THE AREA IS STABILIZED AS ACCEPTED BY THE ENGINEER.

THE TIME ALLOTTED FOR COMPLETION OF THE DEMOLITION OR REMOVAL OF SUCH ITEMS WILL BE BASED ON THE TOTAL OF THE LUMP SUM BID FOR THE BUILDING OR GROUP OF BUILDINGS.
