Declared not needed by United States Government in any plan to connect Lakes Erie & Michigan; and had been appraised at \$300,000.00; and Council of City of Toledo approved said appraisal and elected to purchase; See Resoulution Record Vol. V., P. 9, 9-11-22; and by Ord. No. 2659 on 10-23-22 Council appropriated necessary funds.

On 11-16-22 the State of Ohio, acting by its Governor and Attorney General and the City of Toledo acting by its Mayor and Director of Public Service, thereunto authorized by Ord. No. 2669 adopted by Council 10-30-22 entered into contract per Section 8 of said Act.

The State of Ohio does hereby grant, bargain, sell and convey unto the City of Toledo, ---its successors and assigns forever; for park and boulevard purposes as aforesaid, the following described real estate, to wit: Commencing at the foot of the outlet lock of the Miami and Erie Canal in the City of Toledo, &c., being lock No. 52, of said Canal numbered north from Laramie Summit, and extending thence westerly 1200.0 feet, including the full width of the bed and banks thereof as defined by S.A. Buchanan's survey of said canal made under the direction of the state board of public works in the summer of 1909; also that part of said Miami and Erie Canal commencing at the inner face of the southerly abutment of the old acqueduct over Swan Creek on the Manhattan branch of said Miami and Erie Canal, and extending thence southwesterly over and along said Miami and Erie Canal, including the full width of the bed and banks thereof as defined by Buchanan's survey, for a distance of 45,683.0 feet to a point just below the head of the Maumee ide cut near Maumee, Ohio, excepting therefrom any part of any state lot now under an existing _ease, and likewise excepting therefrom any part of the same that may possibly be required in the construction of any ship or barge canal, under authority of legislation passed or to be passed by the Congress of the United States, or by the State of Ohio. Excepting therefrom and subject to the rights of owners of existing leases of either lands or water or both, and excepting therefrom and subject to the rights of said owners to a renewal of said existing leases.
