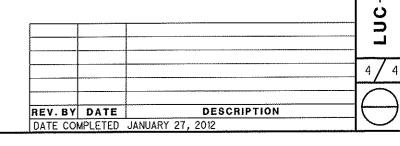
HIGHWAY EASEMENT 11-SH2 DETAIL
