Q1: Under Reference number 7 Plan Page 4 is the intent to install a new 18" Prefabricated Edge Underdrains per Item 611 or is the Underdrain paid under item 605 Reference 3 6" Shallow Pipe Underdrains?

**A1:** Underdrains will be 6" Shallow Pipe Underdrains. There will be no 18" Prefabricated Edge underdrains.

**Q2:** Please add STD BP 2.5 to the Standard drawings for this project and provide a detail for the longitudinal joints as specified in the repair quantity.

**A2:** We will add direction in the plan to refer to BP-2.5 for the transverse joints and to refer to BP-2.1 for the longitudinal joints.
