- 1) The sewer line has been already placed. It was constructed when the new road was being constructed and finished on 4/7/2023.
- 2) The Village of Baltimore initially indicated that they did not need ODOT to purchase a sewer easement to replace their existing sewer easement for this area. However, the Village changed their mind at the last minute and asked ODOT to re-establish the 20-foot easement they had outside of our original highway easement.
