A 2.3% or a \$2.00 convenience fee (whichever is greater) will be assessed on all Credit Card payments. A delinquent charge of \$2.41 may be assessed for each delinquent notice mailed. A Certificate of Judgment can be filed against you for unpaid costs per Section 2335.19 ORC. An additional fee of \$35 for the Certificate of Judgment will be assessed to you for all unpaid court costs. State Law, Section 2335.24 ORC, allows all delinquent judgment to be turned over to a collection agency for collection. The Ohio Attorney General's Office fees of 10% for collection are assessed over and above the costs due.
