Purpose of Meeting: Utility Meeting

#### ITEMS DISCUSSED:

- 1. Mr. Pennington introduced the project. He said the project will be a 17-mile design build, finance, operate, and maintain project. Financial close will be fall 2014. They are anticipating about a 5-year construction period. He passed around the current contact information and asked each utility to verify it contains the correct contact information.
- 2. Each person introduced himself.
- 3. Mr. Pennington said they are about 1 year out from needing utility relocations.
- 4. Mr. Pennington said final plan for Phase 1 were sent out last year.
- 5. AEP distribution said they did not did not receive plans.
- 6. Mr. Barnitz said the plans contain the Department's current design, but they are subject to change. Mr. Wawszkiewicz said plans could only be changed a limited amount. There is a basic configuration that needs to be followed, and the design will be roughly on the same alignment and profile.

- 7. Mr. Pennington said Phase 1 final plans might also change.
- 8. Mr. Pennington said there will be a Stage 1 submittal by the developer, but this could be designed in parts. The developer will also submit final plans.
- 9. Mr. Pennington said the developer would be responsible for all utility coordination.
- 10. Mr. Pennington said developers will negotiate a schedule for rearrangement plans with each utility and that schedule will be used to develop their overall schedule. He stressed this schedule needs to be adhered to. The developer will be responsible to factor in all utility schedules into their master schedule and ODOT will not be responsible for any delays resulting from utility relocations.
- 11. Mr. Pennington said the utilities will submit rearrangement plans and estimates to developer, who will forward to ODOT. The developer will review these plans.
- 12. Mr. Barnitz said the IQF is an independent firm that will act as ODOT's representative to make sure work complies with the project scope documents. Mr. Jones said the developer will submit plans to utilities for review.
- 13. Mr. Wawszkiewicz said there will be interim, final, and released for construction submittals.
- 14.Mr. Pennington said ODOT will determine eligibility for reimbursement and will also process reimbursement.
- 15.Mr. Manzo said ODOT already has an agreement with AEP for the project and possibly Sprint for Phase 1. He will prepare Master Utility Reimbursement Agreement (MURA) for each utility and send out via email. He will verify which MURA are already obtained.
- 16. Mr. Pennington passed out the utility conflict matrix. He wanted each utility to review their respective conflicts and notify him of any errors and omissions for each potential conflict. Advise of any utilities the matrix says they own but they do not own. Notify of any utilities not identified in the matrix. Let Mr. Pennington know of any relocation that will require a longer than standard lead-time.
- 17.Mr. Pennington asked the utility companies to submit documentation for any utility identified as non-reimbursable that they think will be reimbursable.

- 18. Mr. Pennington is looking for a response for item #16 and 17 within two weeks.
- 19. Mr. DeLong said they would not know if their utilities around Highland Bend are impacted until final retaining wall and footers and piers are finalized. They asked of the CD with the route still current. Mr. Barnitz said no and to review the hard copies. Mr. Pack said to review the plans to make sure the utilities are shown correctly on the plans.
- 20. Portsmouth water said some of their water lines are not shown in the southern plans.
- 21. Several Water One sites are not shown or are partially shown. Mr. Barnitz asked if they have mapping and suggested adding this information to the scope documents instead of adding to the plans.
- 22. Mr. Pennington asked the utilities to work closely with the Developer.
- 23.Mr. Pennington asked if the relocations will be bid out and reimbursed. The utilities would like to determine conflicts before they decide on this.
- 24. Portsmouth said their facilities from 140 Gallia St to Ohio River Road will be impacted. Water will be impacted, but they are not sure about sewer conflicts.
- 25.Mr. Barnitz said contract documents will be signed around October 2014. Expect construction in winter 2014, but not sure where construction will start.
- 26. Mr. Barnitz said the Developer will co-locate staff within 2 miles of the project.
- 27. Mr. Pennington ODOT is certain this project will happen.
- 28. Mr. Wawszkiewicz said if any developer asks for specific information, provide this information to Mr. Pennington so this information can be distributed to all developers.

Mr. Manzo verify MURA already obtained for this project. This was described in a October 23, 2013 email from Mr. Manzo.
